ASSIGNMENT: Categorize City-identified missing/inadequate pedestrian and bicycle connections that link neighborhood, recreation centers, and parks in each Ward for City staff to analyze when appropriate funding opportunities arise.

# EXECUTIVE SUMMARY

This report summarizes a multiphase assignment to identify and categorize missing or inadequate sidewalks, shared use paths, and trails. After compiling data from multiple city resources and public input as well as GIS mapping, the project evaluated a total of 431 individual projects across 24 sets of variables resulting in over 10,000 individual data points. The final analysis contains a total of 319 projects for consideration, compiled in a dynamic speed sheet that is both searchable and reconfigurable.

#### BACKGROUND

Sidewalks, shared use paths, and trails are key features of a thriving community; these terms appear in the majority of the plans adopted by the City of Lakewood. However, these projects are also significant investments. The goal of this assignment was to develop tools that the City can use to identify and select appropriate projects when funding opportunities arise (grants, etc).

This assignment presented a unique opportunity for the Lakewood Advisory Commission to partner with City staff. Representatives from Lakewood Community Resources, Amber Thill, and Public Works, Raymond Hill, provided resources, input, and guidance from start to finish. GIS team members also provided mapping instruction and support. The end result are tools (categorization spreadsheet, maps), developed under the supervision of City Staff, which can be maintained and utilized by the City.

# SUMMARY OF RESEARCH AND KEY FINDINGS

Please note that the output of this assignment takes into consideration previous work completed by City staff; it is not intended to take precedence over other existing resources. The output of this assignment can be one part of the toolkit used to analyze funding opportunities when they arise.

The activities associated with this assignment were divided into 4 interrelated categories, each summarized below:

- 1. Categorization spreadsheet
- 2. Mapping
- 3. Resident input

# 4. Equity mapping

# **Categorization Spreadsheet**

The first objective of the spreadsheet was to list all missing connections in a single location. City staff provided 3 resources that served as the foundation of the spreadsheet: the Community Resources Missing Connections List, the Public Works List of Requested Sidewalk Locations, and the Community Resources City of Lakewood Trail Inventory & Connectivity Assessment Report.

Column(s)	Description
А	<b>Project ID:</b> Each row has a unique project ID. Project IDs 22-492 correspond with numbering previously assigned in the Community Resources Missing Connections List. Project IDs 493 and beyond were assigned sequentially in the order projects were entered. Project IDs are not associated with any ranking.
B-D, F, G	These columns contain content from the original resources (the Community Resources Missing Connections List, the Public Works List of Requested Sidewalk Locations, and the Community Resources City of Lakewood Trail Inventory & Connectivity Assessment Report). While each project contains some descriptive information, in many cases, the content was not consistent across resources (eg, length, cost). If the content was not provided in the original resource, "NA" has been entered in the cell.
Е	Ward Number: This information was populated for every project. Some projects span multiple wards.
Н	<b>Origin of Information:</b> This information was populated for every project and indicates the original source of the mission connection

The second objective of the spreadsheet was to research each missing connection and provide information outlined by City staff in the shared use path and sidewalk selection factors in 2019 (Appendix A). Each selection factor described is associated with a points value. The points assigned in the categorization spreadsheet columns J-V follow what was outlined by City staff in the shared use path and sidewalk selection factors in 2019.

Note that the spreadsheet was set up including drop-down menu options in columns J-V. Additional hidden columns are included to allow for points total calculation.

Column	Description
J	<b>Street Classification</b> Each connection was assessed on Google Maps and then compared to the Lakewood Major Street Plan (March 2007) provided by City staff to assign the appropriate street classification.
L	<ul> <li>Transit Stop Within Approximately 1,500 Feet via Pedestrian Route</li> <li>Each connection was assessed on Google Maps to determine the proximity to a transit stop.</li> <li>Google Maps street view images were utilized to determine whether a bus stop included a shelter. According to Google, these images are updated on a 1- to3-year basis; most of these images were last updated in the fall of 2020.</li> </ul>
N	<b>School Within Approximately 1,500 Feet via Pedestrian Route</b> Each connection was assessed on Google Maps to determine the proximity to a school.
Р	<b>Neighborhood Elements Within Approximately 1,500 Feet via Pedestrian</b> <b>Route</b> Each connection was assessed on Google Maps to determine the proximity to one of the defined neighborhood elements.
R	<ul> <li>Site Conditions Google Maps and jMap (Jefferson County mapping) were used to assess site conditions for each connection. City staff provided the following site condition definitions. </li> <li>Right-of-way is available: right-of-way is property owned by the city or CDOT typically for roadway purposes. A rough approximation of existing right-or-way is shown on the GIS Parcel layer overlaid on the current aerial image. Then, based on the standard roadway section, determination is made if there is room to build a sidewalk within the available right-of-way. </li> <li>Completes a missing link: A missing link is a location with a gap in sidewalk improvements (usually a block or less in distance). A missing link has a clear beginning and a clear point of connection where a sidewalk would provide a significant upgrade to connectivity. </li> <li>No sidewalk on opposite side of street: Locations with no sidewalk on either side of the street are viewed as "more in need" over locations that already have a sidewalk on one side of the street. Therefore, locations with no sidewalk on either side of the street receive this designation. </li> </ul>

	imposes a high risk of injury to the traveling public. This is a very subjective matter. The simple lack of a sidewalk does not necessarily constitute a safety hazard. Safety concerns typically escalate with the roadway classification (Local to Arterial). Pedestrian accident history can play a role in identifying a safety hazard. Examples of Potential safety hazards could include: (1) a slope or ditch at the edge of the roadway that does not allow pedestrians relief from passing vehicles; or (2) a culvert crossing that forces pedestrians to walk in the roadway.

City Staff determined that the LAC did not have the tools necessary to assess any of the other consideration factors outlined in the memo.

# Mapping

Once all locations were entered into the categorization spreadsheet, each location was graphed into a geographic information system (GIS) map. This mapping process was only possible with the assistance from City GIS Staff.

Some projects, especially those from the Community Resources City of Lakewood Trail Inventory & Connectivity Assessment Report, included multiple elements for the same location (eg, trail, signage, grading), so only 1 numbered element from the categorization spreadsheet may appear on the map, or numbering may be interrupted.

# **Resident Input**

Once the map showing known missing connections was complete, City staff and the LAC sought resident input on other missing connections. A Lakewood Together "conversation" was open from December 8, 2021, and January 31, 2022 (LakewoodTogether.org/ConnectLakewood; Appendix B). Residents were encouraged to use the interactive map to show missing locations and/or write an idea. In total, 49 connections were provided through this interaction. While this unique opportunity for resident direct input is valued, it appears that most of the 49 connections were provided by just a few commenters, and many were geographically clustered.

After the public interaction was closed, the connections were researched and added to the categorization spreadsheet detailed above.

# **Equity Mapping**

Sidewalks, shared use paths, and trails may be required for residents' access to everyday necessities such as work, school, medical care, grocery store, and bus/light rail, and is especially important for people with disabilities, children, older adults, and those without access to a vehicle. The investment in infrastructure can be a feature in the community and simultaneously reduce disparities.

The Shared Use Path/Sidewalk Selection Factors adopted by the city do not consider any "equity criteria." The LAC worked with City of Lakewood staff to identify the best equity data available that could be associated with each project. After much consideration, the decision was made to work with Denver Regional Council of Governments (DRCOG) vulnerability data from 2019. The data set is more detailed and useful than Centers for Disease Control and Prevention social vulnerability data used on other projects. The DRCOG data are also updated regularly, so the categorization spreadsheet can be refreshed moving forward.

DRCOG vulnerability is scored in 7 categories (bullets below). The index score is the number of categories in which the percent is above the regional average.

- Percent of Persons with a Disability
- Percent of Persons 5 and Over Classified as Language Challenged
- Percent of Minority Persons Including Hispanic and Latino
- Percent of Total Households with No Vehicle Available
- Percent of People (Males and Females) Aged 65 and Over
- Percent of Total Households Below Poverty
- Percent of People (Males and Females) Aged 5 to 17

DRCOG Vulnerability Index Scores were added to the categorization spreadsheet for each project. Following discussion with City staff, the decision was made to make the DRCOG Vulnerability Index Score equal to the points assigned, as opposed to introducing a calculation or weighting.

#### **Points Total**

In an effort to help prioritize the list of projects, points were assigned to columns J, L, N, P, R, and T, which are described in the table above. The individual points associated with each site condition, neighborhood element, proximity to a qualified structure etc., was established by City staff. The points associated with each element were outlined by City staff in the shared use path and sidewalk selection factors in 2019 (Appendix A), with the exception of the DRCOG Vulnerability Index Score previously discussed.

Where two or more elements or conditions were found the points were added. For example, the condition of being near an elementary school was worth 3 points and being near a high school was worth 1 point. If both elements were met, a total of 4 points were given.

After all the points were assigned to each of the identified columns, they were added. When sorted from highest score to lowest score, a ranking of projects was obtained. The ranked projects were then evaluated to determine which columns contributed the most to the overall ranking of projects and their correlation, if any, to the DRCOG Vulnerability Equity Index score. Of note, no additional weight was given to the DRCOG Vulnerability Equity Index score.

Findings:

- The columns that contributed the most to the overall scoring were: "Neighborhood Elements within Approximately 1,500 feet via Pedestrian Route" and "Site Conditions". This is due to the fact that most of the highest-ranking projects met multiple criteria in these two columns which resulted in the summing of scores as described above.
- Taking the DRCOG Vulnerability Equity Index score as an independent variable, there was no direct correlation found between the ranking of projects and the DRCOG Vulnerability Equity Index score. While the top ranked projects do reflect both a high total score and a high DRCOG Vulnerability Equity Index score as one goes down the list one finds the correlation no longer exists.

#### **Review Process**


The final list was condensed from 431 to the final 319 projects visible in the categorization spreadsheet. This included removing projects that:

- are now in place (18),
- are underway or in the design phase (20),
- are infeasible, are the responsibility of a developer (21), or are in the Bear Creek Lake Park Master Plan redesign area, and
- are individual components of a larger project; these were "condensed" into a single line item (53)

#### **Key Findings**


Approximately half of the projects included in the categorization spreadsheet and map pertain to sidewalks; the other projects are a combination of trails, shared use paths, and other. The "other" category includes the following project types: Underpass/overpass, sharrow, easement acquisition, accessibility enhancement, at-grade crossing, bike lane, crossing, bridge, crosswalk, safety enhancement, signage/striping, and surface improvement.

The figure below shows the breakdown of projects by ward; note that some projects span multiple wards. There distribution of missing connections ranges from 11% in Ward 3 to 30% in Ward 2.



#### Missing or Inadequate Connections by Ward Number

Out of 319 items contained in the categorization spreadsheet, 313 were associated with a DRCOG vulnerability index score of at least 1. The figure below shows the breakdown of the scores ranging between 1 and 6.

#### RECOMMENDATIONS

Please note that recommending specific project priorities was outside the purview of the LAC. Instead, the project was designed to create a tool for project evaluation by City staff and elected officials. Moreover, the point values that resulted in ranking were predetermined by City staff. However, with the creation of this tool, any of those values (points) could be reevaluated and easily reassigned different points by City staff as priorities might change over time.

- 1. This report and the accompanying spreadsheet tool should be consulted whenever funding opportunities for projects become available.
- 2. While the DRCOG Vulnerability Index score was a useful variable, it did not appear to have a significant impact on ultimate ranking. As such, consideration should be given whether to assign a higher point value to the score.
- 3. Periodically update the categorization spreadsheet to keep data current.
  - a. Consider keeping the public interaction map as a permanent tool on the Lakewood website so residents have a way to provide notification about missing or inadequate connections.
  - b. Find additional means to make it easier for residents to voice their needs.
  - c. Consider a subsequent project to examine historical infrastructure spending. If historical inequities are identified, find ways to address those inequities.

Subject: PRIORITIZATION OF SHARED USE PATH AND SIDEWALK PROJECTS

#### SUMMARY STATEMENT:

In its 2018 Strategic Plan Goals, the city council established a goal to "improve walkability and safety throughout the community by reevaluating the process used for strategic deployment of sidewalks." This memorandum and the March 4, 2019 study session will outline funding and prioritization factors and the process for evaluating potential shared use path and sidewalk projects. This is an informational update and no council action is requested.

#### BACKGROUND INFORMATION:

Sidewalks and shared-use paths are constructed through a variety of means. This memorandum addresses the stand-alone projects funded by the city's Shared Use Paths/Sidewalks program in the Capital Improvement and Preservation Plan (CIPP).

Other ways, not discussed further in this memorandum, by which paths and walks are constructed include:

- As part of development projects, which are constructed and paid for by the developers such as the walks and paths in Solterra and along the Wadsworth and Jewell frontages of the Green Gables development;
- As part of larger city- or state-initiated roadway or intersection projects such as the paths along Wadsworth between Highland Drive and Colfax;
- As part of parks or trails development such as the Dry Gulch trail; and
- As projects funded by specific grant programs, such as the Community Development Block Grant program funded walk along Pierce north of Colfax.

A list of requested locations is continually updated and currently comprises over 160 locations, equating to over 55 miles with an estimated cost of 75 to 200 million dollars. This list is not a comprehensive inventory of every sidewalk or shared use path needed in the city. The list has been generated by requests from the public, from city council and from city staff. Often referred to as missing links, these are missing sections that, if constructed, would link sections and create longer, continuous shared use paths or sidewalks.

Current annual funding for the Shared Use Paths/Sidewalks program in the CIPP is \$500,000, funded by the Capital Improvement Fund (CIF). The annual amount was increased in 2018 from \$300,000 per year. Requests outweigh available funding and a prioritization process is used to recommend project locations. The cost of some recommended locations exceeds the annual funding amount and money may need to be accumulated in the CIF over more than one year to fund a specific project location.

#### Prioritization process

The process includes the following steps and is described in more detail below:

- 1. Preliminary location ranking
- 2. Multi-departmental team evaluation of location ranking results
- 3. Conceptual designs developed for top ranked locations
- 4. Multi-departmental team review of conceptual designs to determine feasible locations
- 5. Conceptual cost estimates developed for feasible locations
- 6. Selection of recommended project locations
- 7. City council approval

#### 1. Preliminary location ranking

The selection factors are provided in Attachment A. Generally, priority is given to locations on arterial or collector roadways, where traffic speeds are higher and potential conflicts are greater. Priority is given to locations serving pedestrian generators, such as schools, transit stops, parks and recreation centers. Site conditions, such as available publicly-owned rightof-way, ease of construction or ability to correct a safety hazard, are evaluated. Low priority may be given to locations in which future development is anticipated or where the proposed path or sidewalk may be removed due to anticipated changes, such as future road widening.

The requested locations are preliminarily ranked using the points assigned to each selection factor. The selection factors and the point system help keep the location ranking process consistent year-to-year.

#### 2. Multi-departmental team evaluation of location ranking results

A team made up of staff from the Public Works, Planning, Economic Development, Community Resources, Police departments and the City Manager's Office reviews the preliminarily ranked location list using the city's aerial mapping tool. The team discusses community needs, potential conflicts, upcoming development or other projects, and other factors that may affect the ranking. For example, the Police Department representative may request a higher ranking for a location because several disabled residents have recently moved into a specific apartment building and adding sidewalk would improve their access to the nearest bus stop. The Economic Development representative may request a location be removed from consideration because the property is for sale and a prospective buyer is interested in completely redeveloping the site.

The location ranking is adjusted based on the team evaluation and the top ranked projects are identified. This multi-departmental team strives to ensure all known factors are considered including input received over time from the public and, via the City Manager's Office, from City Council.

#### 3. Conceptual designs developed for top ranked locations

Public Works staff develops conceptual level designs for several of the top ranked projects. These conceptual designs identify location, alignment and width of the proposed shared use path or sidewalk. Although no survey work is conducted at this stage, potential constraints and impacts, such as topography challenges, drainage problems, and potential impacts to adjacent properties, are evaluated. The conceptual design is a valuable, cost-effective tool for evaluating the feasibility of a location.

#### 4. Multi-departmental team review of conceptual designs to determine feasible locations

The multi-departmental team reviews the conceptual plans and visits each potential location. The team discusses the design concept and proposes refinements or changes. Major changes to the conceptual design are possible at this stage.

The team site visits and on-site discussions often reveal impacts and benefits that are not readily apparent on a conceptual plan. For example, during the review of a small section of sidewalk, the team determined the sidewalk alignment needed to be revised at the roadway intersection. This necessitated an extension of a large drainage culvert and installation of guardrail. Those changes resulted in a project that was relatively expensive for the short length of sidewalk and the location was removed from consideration. It remains on the list of requests and will be considered as other funding sources become available.

At another location, a well-used footpath highlighted the current need and this location became a higher priority.

#### 5. Conceptual cost estimates developed for feasible locations

Conceptual cost estimates help determine the number of locations and which specific locations can be funded. Conceptual cost estimates include all elements of the anticipated project in addition to the actual construction of the path or sidewalk, including acquisition of needed property rights, retaining walls, fencing, specialty paving, signing, traffic control, or other elements.

#### 6. Selection of recommended project locations

Based on the input through the proceeding steps, Public Works staff makes a recommendation for project locations that will be proposed in the annual budget. The Shared Use Paths/Sidewalks program sheet in the CIPP section of the budget lists the project locations.

An improved public outreach process will be employed prior to the final recommendation for project locations. For each newly recommended project location, a notice will be sent to owners and occupants of properties within 500 feet and registered neighborhood organizations within 1000 feet. Staff will consider all public input received prior to making specific project recommendations.

#### 7. City Council approval

The public process associated with the adoption of the budget will continue to be an opportunity for additional public input. After city council approval of the budget and before survey work and final design begins, Public Works staff contacts owners and occupants of adjacent properties.

#### BUDGETARY IMPACTS:

No additional budgetary impact is anticipated to continue administering the Shared Use Path/Sidewalk program in the CIPP.

#### STAFF RECOMMENDATIONS:

No city council action is requested with this informational update.

#### PUBLIC OUTREACH:

Public outreach to date has been conveyed through the city council agenda for the March 4, 2019 study session. Public input may occur in advance of and during the study session.

#### NEXT STEPS:

No city council action is requested with this informational update.


